## FHWA Releases South Lawrence Trafficway Draft Document

The Federal Highway Administration (FHWA) has released a Draft Section 4(f) Evaluation of the South Lawrence Trafficway (SLT) for public review and comment. The document examines the potential impacts of two alternate alignments for the eastern leg of the SLT – 32<sup>nd</sup> Street Alignment B and 42<sup>nd</sup> Street Alignment A – on historic properties and publicly-owned natural areas. Two properties are addressed – the Haskell Agricultural Farm Property, which includes the Baker Wetlands, and the William Meairs Farmstead south of the Wakarusa River. The Evaluation also discusses measures to mitigate possible impacts on the properties.

All comments on the Draft Section 4(f) Evaluation must be submitted in writing on or before January 5, 2007 to Wendall L. Meyer, Assistant Division Administrator, FHWA, Kansas Division Office, 6111 SW 29th Street, Topeka, KS 66614. Anyone who has questions may contact Mr. Meyer at 785-228-2544. The FHWA will consider all comments received as it develops the Final Section 4(f) Evaluation.

The FHWA will host an informal open house in December so the public can participate in the Section 4(f) Evaluation process. Visitors to the open house will be able to learn about potential impacts on the two properties and possible mitigation measures, talk with the project team, and provide comments in an informal setting. Details about the open house will be announced later.

### **FHWA Role in the Project**

The FHWA became involved with the SLT in November 2005 because of a \$1.5 million federal appropriation to resume development of the project, which is estimated to cost more than \$110 million to build. The funds will not be sufficient to start construction of the project. No other federal or state funding has been identified, so no construction is scheduled.

Another federal agency, the U.S. Army Corps of Engineers, released its approved Final Environmental Impact Statement (FEIS) for the SLT in January 2003. In its Record of Decision in December 2003, the Corps selected 32<sup>nd</sup> Street Alignment B as its preferred alternative. On April 10, 2006, the FHWA announced its intent to adopt the Corp's approved FEIS and also announced it would prepare and coordinate the distribution of a Draft and Final Section 4(f) Evaluation for the project. After considering comments, the FHWA will release its own Record of Decision and the Final Section 4(f) Evaluation in Spring 2007.

## **BACKGROUND**

Section 4(f) of the U.S. Department of Transportation Act of 1966 (as amended) applies specifically to projects involving federal funding for transportation improvements. It is intended to protect publicly-owned land of a publicly-owned park; recreation area; wildlife and/or waterfowl refuge of national, state, or local significance; or land of a historic site of national, state, or local significance from conversion to transportation use unless two provisions are met:

1. There is no feasible and prudent alternative to the use of the land from the property; and
2. The action includes all possible planning to minimize harm to the property resulting from such use.

The SLT project consists of building a new section of K-10 Highway beginning at the K-10/ US-59 Highway interchange in southwest Lawrence extending approximately six miles north and east to the existing K-10 near the eastern edge of the city of Lawrence. The No-Action alternative and five roadway corridors with a total of twelve reasonable-build alternative alignments were evaluated and discussed in the Draft and Final EIS. The preferred and selected alternative in the Corp's approved FEIS would build a limited access freeway along the southern edge of the city on an alignment identified as 32nd Street Alignment B.
